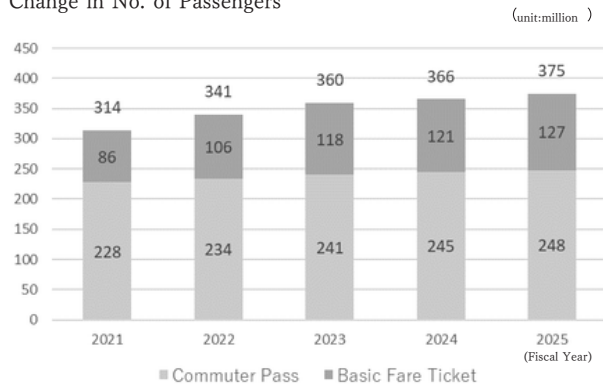

### Change in No. of Passengers



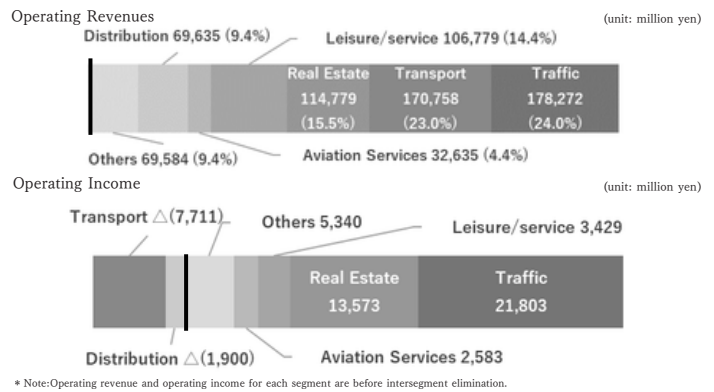

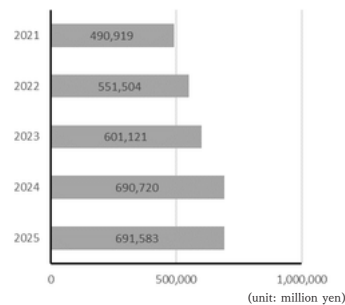

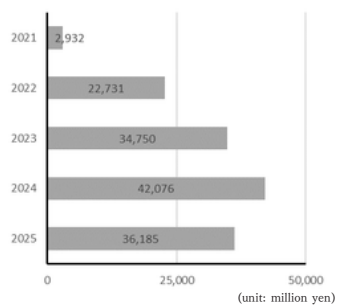

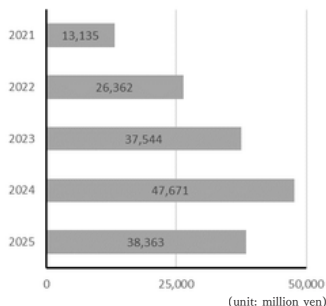
#### Operating Revenues (Fiscal Year)
